

ALABAMA BOARD OF COSMETOLOGY & BARBERING MINUTES OF THE BOARD MEETING RSA Union | Suite 300 Montgomery, Alabama

October 17, 2022 10:00 A.M.

Board Chairman Mr. Floyd McDonald called the meeting to order at 10:01 am and presided over the meeting.

The invocation was given by Ms. Linden and the roll call was taken by Mr. McDonald. The Board Members present were Mr. Daniel Powers, Ms. Misty Garrison, Ms. Michelle Callahan-Alvis, Ms. Kathy Linden, and Mr. Floyd McDonald. Mr. General Jackson was absent. A quorum of the Board Members was present. Ms. Jeannie Price was present, as Executive Director, and Ms. Neva Conway was present as legal counsel. The office staff members present were Susan Jana and Madison Johnson. There were also public visitors present, as noted on the sign-in sheet.

Mr. McDonald asked if the Board Members had received and read the agenda for October 17, 2022. All members present confirmed they had and that there were no questions. With all ayes, the agenda was adopted.

Mr. McDonald asked if the Board Members present had received and read the minutes from the July 11, 2022, Board Meeting. All members present confirmed they had and that there were no questions. Ms. Callahan-Alvis made a motion to adopt the minutes from the July 11, 2022, meeting, Mr. Powers seconded, and with all ayes, the motion was carried.

The complaint and the Administrative Law Judge's recommendation were read by Ms. Price.

Complaint #4071 —The Hair Shack and Erica Young: \$750 fine plus administrative court costs. Ms. Price made an addendum to suspend the Ms. Erica Young's license if the amounts are not paid. Ms. Linden made a motion to accept the Judge's Recommendations and the addendum, and Ms. Callahan-Alvis seconded, with all ayes the motion was carried.

Mr. McDonald asked if all Board members received a copy of the Financial Status Report covering the period 10/01/21 through 09/30/22. All members indicated they had received and reviewed this report and there were no questions.

Mr. McDonald invited Mr. Anthony Ingram with the Shoals Hair Co. Academy to speak for five minutes. Mr. Ingram and his wife Ms. Tiffany Ingram spoke on their love for the cosmetology field and their wish to help people in the Shoals area obtain a license. Ms. Linden made a motion to approve the New School application and Ms. Callahan-Alvis seconded and with all ayes, the motion passed.



Ms. Conway led the election of Officers for 2023. Ms. Linden nominated Mr. McDonald to serve as Chairman. With all ayes, Mr. McDonald was elected. Mr. McDonald nominated Ms. Linden to serve as Vice-Chair. With all ayes, Ms. Linden was elected. Mr. McDonald nominated Mr. Powers to serve as Secretary/Treasurer. With all ayes, Mr. Powers was elected. Ms. Linden nominated Ms. Callahan-Alvis to serve as the Investigative Committee member. With all ayes, Ms. Callahan-Alvis was elected.

Proposed dates for 2023 Board Meeting were 1/23/2023, 4/17/2023, 7/17/2023, and 10/16/2023. With all ayes, the 2023 meeting dates were accepted.

Ms. Price spoke on the possible changes to the apprenticeship program. The changes would need to be passed through the legislature, and all the Board members agreed to proceed with the next steps.

Mr. McDonald asked if there was any other business to be addressed. With no responses to the affirmative, Mr. Jackson made a motion to adjourn the meeting and with all ayes, the meeting was adjourned at 10:24 am
